BUSINESS

• Candidate Environmental Scorecards:

The group's concensus was to limit the scope of the scorecards to locally elected candidates. (it was not determined whether to extend this to some limit beyond Brainerd/Baxter municipal and Legistative District 10A/B candidates).

The CWA and LCV links provided in the agenda both appear to provide useful information toward the purpose of creating the BLUE scorecard. The Indivisible link just went to sending them an email, one was sent requesting the BLUE email address be added to their mailing list, but no response has been received to date.

An on-line search for additional sites which yielded a list of forty plus links that will be attached to the mailing of these minutes. To facilitate a review of these sites we decided to split the list for members to review. Dean will take links numbered 1-10, Judi/Richard links #11-20, Pat links #21-30, Karen links #31-40, Sharli links #41 and above, as well as the two 'Other Websites of Interest' listed below. Please render your opinion on whether the site would have value (yes/no) to be monitored in regard to preparing our scorecard in time for our August meeting.

We had a limited discussion on how to distribute the scorecards beyond our mailing list. Suggestions were to provide it to the Hickman's for their news letter and to place it in the Dispatch. Any other ideas are welcome.

- Electric vehicle event Melissa has been unable to gain support from dealers, as they are not able to guarantee the availability of vehicles on their lots, so this project is indefinitely suspended. If members know of any private owners of E-Vs who might be amenable to participating in a demonstration event, please advise BLUE and perhaps we can rekindle this event. It was suggested a firm date for such an vent should be set and if dealerships happen to have an E-V in stock they could participate. This action aligns with the UN Climate Change Summit in NY thefourth week in September 2019.
- BLUE's participation in the Brainerd 4th of July Parade was assessed to have been a success by the members present.
- If the parade float is to be rebuilt it was suggested the decking be replaced with 5/4" treated lumber rather than plywood.
